2. The Chairperson, Internal Procurement and Disposal of Assets Committee, CMST now invites sealed bids from eligible and qualified bidders for the supply, delivery and installation of motor vehicle tracking and fuel monitoring system:
3. Bidding will be conducted through **National Competitive Bidding (NCB)** procedures specified in accordance with the Public Procurement Act 2003 and Public Procurement Regulations 2004 of the Government of the Republic of Malawi, and are open to all eligible bidders.

5. A Bidding Document in English Language may be purchased by interested bidders from the address at 8(a) below upon payment of a non-refundable fee of MWK 5,000.00 to the address at 8(b) below. The method of payment will be Malawi Kwacha either in cash or a bank certified cheque.
6. Bids must be accompanied by a Bid Security of **MK2,000,000.00** or a **Bid Securing Declaration Form**, if the company of the bidder is 100% owned by Malawi National(s). The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.

7. Bids must be deposited in the Tender Box at address 8(c) below on or before **3rd December 2018 at 14.00 hours local time**. Electronic bidding *will not* be permitted and Late Bids will be rejected.
